

**LIST OF SOME PRODUCTS INTRODUCED BY  
INDIVIDUALS IN NEW CALEDONIA  
NOT REQUIRING IMPORT PERMIT AND  
CERTIFICATE**

New Caledonia is free from numerous diseases and parasites affecting humans, animals and plants, which are present in other parts of the world. The New Caledonian's laws do take these particularities into account in order to maintain the exceptional status of the island.

Consequently, all animals, animal products or products from animal origin, plants, plant products, and minerals are to be declared when entering New Caledonia and must be covered by appropriate veterinary and/or phytosanitary certificate.

Some products may be imported by individuals without import permits and/or sanitary certificates. The list of products presented hereafter sums up these exemptions. This list can be modified anytime without warning following new sanitary information. In all cases these products may be declared or will be seized.

The limit is set to 5 kg per passenger or mail parcel.

The cornerstone of New Caledonia's legislation regulating the import of goods hereafter mentioned is the regulation n°2014-333/GNC dated 13th of February 2014.


In this document:

- By authorized without any additional notes, means authorized from all countries. Inspection will verify sanitary harmlessness of the product to New Caledonia;
- By commercial is meant unbroken packaging, with adequate labelling which indicates identification of the product, country of fabrication, name and address of the processing establishment, weight, ingredients and health mark if appropriate;
- By preserve is meant a preparation that has undergone thermal treatment, in a sealed container liquids and gas tight. As an example, a product that requires a conservation temperature +2/+4°C is not a conserve.

Commercial preserved milk whatever the conditioning	Authorized

Commercial cheese made with canned milk, pasteurized milk (refer to the labeling)	Authorized for countries in the list [B]
<b>BEE PRODUCTS</b>	
Commercial honey, excluding honeycomb, in commercial conditioning inferior or equal to 1kg (500g for Vanuatu)	Authorized for countries in the list [C]
Royal jelly in pills and propolis in capsules or in solution	
<b>SEAFOODS AND FRESH WATER</b>	
Eviscerated fish	Authorized
Dead molluscs shelled: mussels, snails	
Dried sea cucumbers	
<b>EGG PRODUCTS</b>	
Eggshell, empty and cleaned	Authorized
<b>CAKES</b>	
Cakes with cooked ingredients	Authorized
<b>MEAT</b>	
Commercial jerky	Authorized (only origin and source Australia and New Zealand)

<b>HIDES AND SKINS</b>	
Worked tanned skin (or leather)	Authorized
<b>FEATHERS / WOOL / ANIMAL HAIR</b>	
Treated or tinted	Authorized
<b>BONES / HORNS / HOOVES</b>	
Articles worked (varnish ...)	Authorized
<b>FOOD FOR DOMESTIC ANIMALS</b>	
Commercial food having undergone heat sterilizing treatment without any crustaceans based ingredients (croquettes, caned)	Authorized for countries in the list [D]
Commercial toys that have undergone heat treatment (bones in buffalo skins ...)	

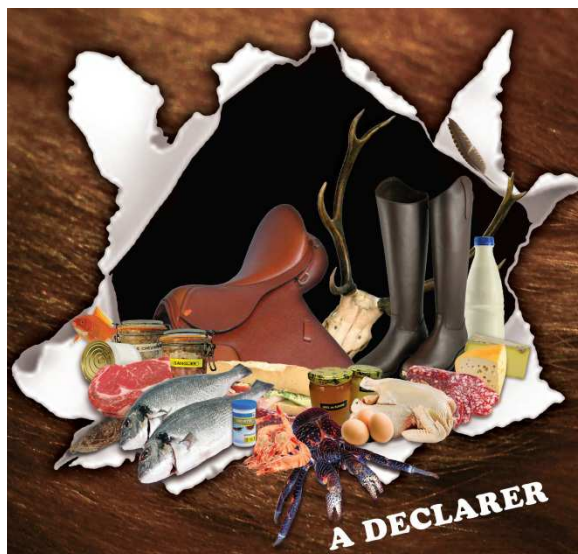

<b>FRUITS</b>	
Depp frozen, cooked or marinated fruits: jams, fruits in syrup	Authorized
Commercial dried fruits except citrus fruits: dried bananas, dried apricots, dried dates, dried figs, dried chilli, dried vanilla pods...	
Dried raw nuts depulped or deshucked: almonds, chestnuts, hazelnuts, Chilean hazelnuts, nuts (type walnuts), Brazil nuts, cashew nuts, pecan nuts	
<b>VEGETABLES AND TUBERS</b>	
Clean identified mushrooms	Authorized <sup>(CUSTOMS)</sup>
Frozen, cooked or marinated vegetables	Authorized
Dried vegetables and grains for human consumption, in commercial conditioning, except cereals with glumes, corn, sorghum, soy, sunflower and raw peanuts	Authorized in conditioning inferior or equal to 1kg
Popcorn in microwavable packaging	Authorized
<b>Seeds for sprouting</b> for human consumption in commercial packaging except species subject to additional declarations	Authorized <sup>(1)</sup> Limit of 10 commercial bags / trays of 500gr maximum. The labeling must specify the name of the species
<b>Sprouted seeds</b> for human consumption in commercial packaging	Authorized <sup>(1)</sup> Limit of 10 commercial bags / trays of 500gr maximum. The labeling must specify the name of the species
<b>TROPICAL TUBERS</b>	
Yams, taros, sweet potatoes, cassava, peeled and frozen or cooked	Authorized <sup>(CUSTOMS)</sup>
<b>PLANTS AND PLANT PRODUCTS</b>	
Dried plants, medicinal herbs included, without citrus fruits and seeds/ Potpourri, infusion mixes, green tea...	Authorized
Dried or fresh seaweed for consumption having undergone transformation, in commercial packaging	
<b>SEEDS</b>	
Commercial vegetable, flower or ornamental seeds (The labeling must specify the seed name, lot number, trade name and address of the conditioner)	Authorized for authorized species (CITES) in this regulation and not requiring mentions or phytosanitary treatments <sup>(1)</sup>

	Limit of 10 commercial bags of 10 gr maximum. <b>The packaging must certify the absence of GMO or failing this, a "non-GMO" certificate of a commercial nature must accompany the goods.</b>
<b>OBJETS D'ART EN BOIS ET VANNERIES</b>	
Vegetable fiber baskets, wooden sculptures without animal by-products (ex feathers ...)	Authorized <sup>(2)</sup> (CITES)
<b>SPICES</b>	
Spices in powder	Authorized
Raw known spices (nutmeg, cloves, cardamom, saffron, cinnamon...)	
<b>ANIMAL FOOD</b>	
Extruded food for herbivores and granivores (pellets, flakes, commercial preserves...)	Authorized
<b>SUBSTRAT</b>	
Clean sand without organic matter and plant material...	Authorized

(1) ⇒ Except the following species: *Allium spp*, *Helianthus spp* (of which sunflower), alfalfa, corn, soy, sorghum. Caution, this list is not exhaustive, in case of doubt, contact SIVAP.

(2) ⇒ Following the inspection on arrival, possible corrective treatment at the expense of the importer.

Even authorized, any product of animal or vegetable origin must be declared on arrival in New Caledonia under penalty of seizure.

It can also be visually inspected by biosecurity.
